For the Owner, Owner's Representative or Captain

I, ______, Owner / Owner's Representative / Captain of the vessel _____, in order to comply with French Law while sailing in the French waters surrounding St. Barths, hereby certify that:

- The yacht and its owner are validly covered for their civil liability all material and immaterial damages included within the conditions of this type of private nautical race; and this with a minimum guarantee of €10,000,000 (or the equivalent in other currencies). (NOR Part 1, Section 9 INSURANCE).
- All of the yacht's insurance carriers have been notified regarding the Vessel's participation in the 2025
 St Barths Bucket Regatta and all crew and guests aboard are held covered.
- All French citizens among their crew are in possession of a valid FFV Sailing License.
- All crewmembers of other nationality are covered by appropriate civil liability insurance.
- The Captain has advised the crew about the potential dangers of racing, including increased loads.
- The Captain will take appropriate measures to ensure the safety of visiting guests both underway and dockside.
- I have read and understand the Notice of Race (NOR), and Sailing Instructions (SI) and agree to be bound by the terms of the NOR, SI, and the rules as defined by *The Racing Rules of Sailing*.
- Captain and Owner / Charterer further agree to all terms and conditions set forth below.

For the Crew and Guests aboard the Yacht

- 1. I confirm that I have read and understand the terms contained in this 2025 St Barths Bucket Disclaimer of Liability.
- 2. By signing this Disclaimer I agree to be bound by the terms of this Disclaimer
- 3. I understand and accept that the Regatta Organizers (as defined below) exclude all liability for property damage, personal injury or death sustained at sea or on land in conjunction with, prior to, during or after the Regatta to the fullest extent permitted by law. If assistance is provided by any Regatta support vessel or personnel, it is at the sole risk of the participants.
- 4. On behalf of my administrators, executives, heirs, next of kin and assigns, and myself, I hereby waive any and all claims, rights of action, or any type of demand of any nature whatsoever against the St Barths Bucket Regatta and the Regatta Organizers, including any and all claims for damage or injury caused by accident or by the negligence of any of the foregoing arising out of my participation or that of my yacht in the Regatta and its related activities, including pre-start and post-finish operations and shore activities, together with any costs and expenses, including attorney's fees that may be incurred as a result of any such claim whether valid or not.
- 5. The term "Regatta Organizers" shall include, but is not limited to, the Bucket Events SAS, all sponsors and all other affiliated organizations and individuals including: any associated company, consultants or agents, race committee, race officer, support boat, employees, and volunteers involved in the 2025 St Barths Bucket Regatta.
- 6. I understand and accept that participating in or practicing for the Bucket Regatta may involve substantial risk of property damage and personal injury.
- 7. I understand and accept that the Captain is responsible for deciding whether the yacht is seaworthy and/or fit to sail, and that the crew is competent to sail, in any conditions that may be encountered, and the insurance is sufficient and valid for coverage of ship and crew. In all circumstances, the Captain is fully responsible for the decision to participate in each race or to continue racing at any time.
